As of December 31, 2022 account balances total \$56,330. Tom proposed converting the \$37K in the Schwab account into higher yielding 18 month CDs (4.65%). Gene agreed to act as Assistant Treasurer and have signature authority along with the President and Treasurer.

### 5.2 Membership Update

Latest in/out report shows 1237 members, down 112 from a year ago.
